

## UNITED RENTALS – RENTAL PROTECTION PLAN

Rental Protection Plan – United Kingdom (English)

Addendum to Rental and Service Agreement Terms

Last Update: 19 April 2023

The Rental Protection Plan ("**RPP**") is an optional product described in this addendum (the "**Addendum**") that modifies certain terms of the Rental and Service Agreement entered into between United and Customer. The definitions set forth in Section 1 of the Rental and Service Agreement apply to this Addendum.

### **NOTICE:**

**FOR ALL RENTALS OF EQUIPMENT NOT LICENSED FOR ROAD USE, YOU MUST EITHER SHOW PROOF OF PROPERTY INSURANCE IN ACCORDANCE WITH SECTION 21 OF THE RENTAL AND SERVICE TERMS OR PURCHASE THE RENTAL PROTECTION PLAN. THE PURCHASE OF THE RENTAL PROTECTION PLAN FOR RENTALS OF EQUIPMENT IS NOT MANDATORY AND MAY BE DECLINED IF YOU HAVE PROOF OF INSURANCE AS REQUIRED BY SECTION 21 OF THE RENTAL AND SERVICE TERMS.**

**RPP IS NOT INSURANCE. RPP IS AVAILABLE TO CUSTOMERS IN CONNECTION WITH THE RENTAL OF EQUIPMENT FROM UNITED AND MUST BE EXECUTED SIMULTANEOUSLY WITH A RENTAL AND SERVICE AGREEMENT.**

**FOR AN ADDITIONAL CHARGE, RPP OFFERS A DAMAGE WAIVER TO LIMIT YOUR FINANCIAL RESPONSIBILITY UNDER EXISTING LAWS OR UNDER THE RENTAL AND SERVICE AGREEMENT FOR DAMAGE TO, OR THEFT OF, THE EQUIPMENT. BEFORE DECIDING WHETHER TO PURCHASE THE DAMAGE WAIVER YOU MAY WISH TO DETERMINE WHETHER YOUR OWN INSURANCE COVERAGE AFFORDS YOU COVERAGE FOR SUCH FINANCIAL RESPONSIBILITY RELATING TO DAMAGE TO, OR THEFT OF, THE EQUIPMENT AND THE AMOUNT OF THE DEDUCTIBLE UNDER YOUR OWN INSURANCE COVERAGE. READ THIS ADDENDUM CAREFULLY BEFORE SIGNING.**

### **TERMS AND CONDITIONS**

In return for payment of the fee set forth in the Rental and Service Agreement for the Rental Protection Plan, United agrees to limit its rights under the Rental and Service Agreement (in particular Sections 11 and 21) and under local Regulations as follows:

#### **A. DAMAGE WAIVER**

Subject to the conditions set forth herein, United waives its rights to collect amounts from Customer exceeding the lesser of 10% of replacement value of the Equipment, 10% of the

cost of repairs or GBP 500 plus state and local taxes, from losses arising from theft of or direct physical damage to the Equipment.

## **B. USER**

Customer agrees that Customer or a permissive user of a Customer will be the only driver of any United vehicle, and that Customer will not use the vehicle in violation of any terms of the Rental and Service Agreement or law.

## **C. EXCLUSIONS**

United will not waive any claim for loss or damage to tires and tubes caused by blow out, bruises, cuts, punctures or other causes inherent in the use of the Equipment: or resulting from intentional, deliberate, wilful or malicious abuse or misuse of the Equipment. Such losses shall remain subject to Section 21 of the Rental and Service Agreement.

## **D. FEE**

Customer shall pay a fee equal to 10% of the rental charges under the Rental and Service Agreement, plus applicable state and local taxes, in exchange for participation in the RPP as set forth in this Addendum.
